- g) Additional Charge to Membership Committee:
 - Look at issues related to non terminal degree service on graduate committees.
 - A. Current Practice in OGS: if a member is listed who is not on the graduate faculty list, then OGS will request that a vita showing educational background be attached to the form to ensure that they do have the terminal degree or at least an equivalent in the case of a master's committee
 - B. Possible wording to consider, with suggested implementation procedures:
 - a. For Doctoral:
 - i. "All members of a doctoral committee must hold a terminal degree in their field unless reasonable written justification is provided from the department to the dean of graduate studies."
 - ii. How to Implement: If a committee member does not hold graduate faculty membership, a vita showing educational background must be provided and attached to the Form 5/5-A upon submission, along with justification if the member does not hold a terminal degree." (This information could be placed in the Instructions tab of the Form 5/5-A)
 - b. For Master's:
 - i. "All members of a master's thesis committee, at minimum, must hold a degree of equivalence unless reasonable written justification is provided from the department to the dean of graduate studies."
 - ii. How to Implement: If a committee member does not hold graduate faculty membership, a vita showing educational background must be provided and attached to the Form 1/1-A upon submission,

along with justification if the member does not hold a degree of equivalence." (This information could be placed in the Instructions tab of the Form 1/1-A)
