President Steven Corns called the meeting to order, 12:00 pm

- 1. Roll call-J. Winiarz
- 2. Approval of minutes from October 14th meeting. Motion to approve as written: Stanley; second: Landers; approved
- 3. Overview of DARS Automation for Graduate Students, provided by Deanne Jackson and Julie Parker from the Registrar's Office
 - a. Problems lie in distinction between thesis and non-thesis Master's degrees
 - b. Major overhaul would be required
 - c. Prefilled form 1 may be possible solution which would be used for all incoming students
 - i. Could then be substituted with traditional form 1 for thesis students
 - ii. A meeting will be called for interested parties involving Dr. Morgan (Curriculum Committee) and Dr. Corns (whose Dept. has instituted prefilled form 1)
- 4. Stipend X Subcommittee consisting of D. Enke (replacing Dr. Landers), A. Alajo, and M. Insall
 - a. Brief report provided by Dr. Insall
 - i. Looking at other campuses (ex. Texas A&M) as potential models
 - ii. May be possible for Depts. to pay tuition and then withhold from student's paycheck, saving student ~\$100 in taxes
 - b. Discussion occurred expressing the need to institute tuition waivers and that requirement to put tuition on grants is not an ideal solution
 - c. Office of Graduate Studies is currently assessing various options which would address the issue globally and expressed willingness to work with any interested committees
 - i. Suggestions may be forwarded to Dr. Allada anonymously (via Dr. Corns) or not
- 5. Replace all instances of 6099 with "graduate research" in the Graduate Catalog front matter
 - a. Insall; second: Weidner; approved
- 6. Title IX graduate course syllabus content included on all syllabi distributed or posted
 - a. Cannot be required but only suggested
 - b. By laws will be checked to see if this is in the prevue of the GFC and discussed at next meeting
- 7. Awards Process
 - a. Committee should be formed with tentative charge "to establish guidelines and criteria for awarding graduate staff and faculty excellence"
 - b. Awarded faculty must be member of Graduate Faculty
 - c. Dr. Corns will solicit suggestions for changes to charge by email
