- 6) Proposed Resolution in Support of Graduate Faculty Status of Emeritus Faculty

    - Recalling CRR 320.090 Emeritus designation where the granting of the title of Professor Emeritus/Emerita or Associate Professor Emeritus/Emerita is reserved for faculty whose contributions to the department and the university are recognized as meritorious as determined by a majority vote of the tenured members of the department;

Recalling Graduate Faculty Rules and Regulations where any member of the Graduate Faculty who is granted Emeritus status shall retain full membership rights and privileges for the remainder of their affiliation with the University;

Therefore, we, the Graduate Council of the Missouri University of Science and Technology reaffirm our respect and support for our colleagues who have attained Emeritus/Emerita status and reaffirm our desire that these colleagues continue to enjoy the full membership rights and privileges of the Graduate Faculty including, but not limited to, serving as the advisor of a graduate student or serving on graduate committees as outlined in the Graduate Faculty Rules and Regulations.
