## Graduate Council Meeting Minutes 12:00 pm, Wednesday, November 04, 2020 Zoom

- 2) Approval of Minutes from October 7, 2020 meeting
  - S. Stanley moved to approve; K. Perry seconded. Unanimous approval by yes votes via Zoom.
- 3) Informational (M. Insall): Should the Rules and Regulations be Modified to Include Vice Provost of Enrollment Management as Ex officio Member of Graduate Faculty? To be discussed further in February, 2021
  - S. Corns clarification Graduate Faculty or Graduate Council seek clarification and explain in February, 2021
- 4) Graduate Forms Review Committee Recommendation of New/Revised Forms for Graduate Students to Reflect Changes in the FS20 Graduate Catalog
  - S. Corns clarification appearance of discrepancy about five signatures on Forms 1B and 3 versus three signatures on Forms 1 and 2. Addressed by graduate of office (master's non-thesis committees require five members vs three for master's thesis committees).
  - Forms submitted from committee (therefore, no need for second). Unanimous approval by yes votes via Zoom.
- 5) Elections for 2020-21 End of Year Awards Committee (Nominees: A. Adekpedjou, V.P. Reddy, G. Olbricht, H. Zhang, staff member Jeannie Werner from CArE)
  - S. Corns moved to approve; S. Stanley seconded. Unanimous approval by yes votes via Zoom.
- 6) Proposed amendment to FS20 Graduate Catalog to Adjust Coursework and Research Requirements for Doctoral Students without a Master's
  - M. Moats moved to approve; S. Stanley seconded. Approval by 11 yes votes, 1 no vote via Zoom.

- 7) Presentation from Sara Fayek, Council of Graduate Students President
  - Concern regarding a "living wage" (0.25% FTE stipend and stipend X amount, given inflation, insurance, fees, etc create a current condition where students are not receiving a "living wage")
  - Proposed graduate student bill of rights draft details discussed in oral presentation
  - Volunteers to serve on the ad hoc committee on Graduate Student Bill of Rights: C.R. Kueny, S. Fayek. Important to include additional representatives from Title IX, Graduate Office, etc.
- 8) Informational (C. Tsatsoulis): Including Student Insurance on External Grant Proposals
  - International students pay approximately \$2,000 per student per year for insurance; domestic students pay approximately \$6,000 per student per year for insurance.

- Informational (M. Insall): Concern regarding undergraduate student simultaneously receiving baccalaureate and graduate degrees; and potential concerns for unforeseen circumstances with students completing a graduate degree before completing a baccalaureate degree.
