## **Qualifying Examination**

A qualifying examination will be administered by the student's academic department and the results must be reported on the Form 4 by the department chair to the dean of graduate studies. The results of this examination will allow the student's advisory committee to assess the student's level of preparation for the doctoral degree and will assist the committee in helping to plan the student's plan of study (Form 5). The qualifying examination must be passed no later than the fifth semester of enrollment in a doctoral program. Students who fail to comply with the deadline to submit the Form 4 will have a registration hold placed on their account by the office of graduate studies. A student who fails the examination twice will no longer be eligible to receive a graduate degree from that program. However, the student is eligible to pursue a graduate degree from any other graduate degree program willing to accept them.
