- 5. Provost/Interim Vice Provost of Graduate Education Dr. John Harris
 - a. The number of PhD students is a metric for R1 status, which garnered in January, would be very embarrassing to lose.
 - b. The GFC needs to focus on recruiting PhD students.
 - i. Through networking with existing contacts, especially at non-PhD granting institutions.
 - ii. Collaboration (with 'sister' universities) and online PhD programs are being explored.
 - iii. Several challenges and suggestions were raised by the GFC including those below.

- The current tuition structure, and the need for PIs to cover these and similar costs through their grants pose some significant challenges.
 - a. Provost Harris pointed out that at least partial coverage of tuition is being considered.
- Current graduate students should be better utilized for our recruitment efforts based on their familiarity with their home regions/countries, our university and the visa process.
- The lack of flexibility in the graduate students' pay scale poses a challenge.
- The need for graduate students to cover their own insurance poses a barrier to recruitment.
- The current graduate and undergraduate tuition rates are in the attached addendum.
- Conflicting messages as to whether we need to focus on master's or PhD graduate students poses a challenge.
- c. We need to look for a way to help post-Docs find community.
- d. Discussion was initiated concerning the creation of a Graduate School and recruitment for an associated Dean.

6. Stipend X

- a. A number needs to be proposed by the end of November.
- b. Data will be collected and disseminated to have an informed conversation at the next meeting.
- 7. Discussion on Graduate Student Recruitment Ideas for recruitment are requested.
